It is understood that Sea Tow Services International, Inc. and its franchisees, licensees, organization, providers and agents (all defined for this limitation as "Sea Tow") will not be responsible for property damage or personal injury sustained by any member, vessel, cargo, or passenger including: while services are being rendered, during any waiting period, and/or due to weather conditions or mechanical and physical restriction beyond human control. Sea Tow will not be held liable for invoices or bills of any other towing company. Sea Tow must be used where its coverage is available. Members assume all risk of towing and all other services required, and hereby hold Sea Tow harmless in all such respects, in all instances other than gross negligence. In the event of any emergency, threat of or actual injury to persons aboard ship or any occurrence that threatens the safety of passengers or vessel, member MUST immediately contact the U.S. Coast Guard and request emergency assistance. Service will vary by area and by season, and are subject to the discretion of the provider in light of the circumstances then present. Sea Tow reserves the right to terminate or limit this membership for any abuse. Intoxicated parties may be refused service!
